This procedure is subject to a general fee of 3000 HUF based on paragraph 29 of the Act XCIII. of 1990 on Fees. The procedural fee can be paid also by bank transfer to account no. **10023002-01780499-00000000** of Ministry of Defence Hungary, which is managed at the Bureau of National Tax and Customs of Hungary. In case of this way of payment, the invoice of the bank transfer has to be attached to the application form. The rules for applying and using temporary designated airspace(s) are set forth in Act No. 4/1998 on the Application of the Hungarian Airspace. The application must be submitted at least 30 days prior to the intended use and can be used for maximum 30 days.

This application form must be submitted as per the number of temporary designated airspace claims. One form is suitable for claiming only one temporary designated airspace.

<sup>2</sup> Person or service provider, who is responsible for organizing air traffic and the direct execution of the activity indicated in the justification.

<sup>3</sup> Tasks of the responsible airspace claimant: submitting this application form with all the required attachments, activation of the airspace at Budapest ATS Centre, organizing and coordinating the activity mentioned in justification, and approval of overflight of the temporary designated airspace.
